The Town Clerk and Chief Executive, Borough Treasurer and Borough Engineer and Surveyor were in attendance.

1. Minute's Silence

The Council stood for a minute's silence as a mark of respect to Councillor Mrs. Doreen Kinrade, and Mr. Robin Gibb, both of whom had recently died.

2. **Minutes – 9th May 2012**

Minutes of the annual meeting held Wednesday, 9th May, 2012, were approved and signed.

3. Questions – Mr. Councillor C.C. Thomas

The following question addressed by Mr. Councillor C.C. Thomas to the Lead Member for Regeneration and Community Advisory Committee, having been circulated together with the Lead Member's reply was noted:

Question:

In respect of the Noble's Park bowling-green kiosk part of which provides a bowling clubhouse;

- (i) How were the following costs estimated i) £215,000 to fully refurbish or rebuild the building ii) £148,000 to retain the club house but demolish the toilets;
- (ii) Were quotations or estimates obtained from potential contractors to inform these estimates and, if so, how and when:
- (iii) Was professional opinion sought and obtained for these estimates;
- (iv) How much has the Council spent on maintenance in each of the last ten years;
- (v) What, if anything, has the Committee learned from its decision to reconsider the previously agreed demolition in respect of i) maintenance ii) dialogue with users and the wider community iii) the process of estimating refurbishment and iv) the provision of information as such decisions are taken?

Reply:

The question of the Noble's Park Bowling Pavilion Building is still under consideration by the advisory Committee and as can be seen in the minutes of the last meeting, Members have asked for all relevant information. Representatives of the Bowling Club that occupies the pavilion have also been invited to the next meeting.

It is premature to go into too much detail at this stage but the Member can be assured that no final decision will be made until the Committee is in possession of all material information.

In relation to the estimated costs, and how they were arrived at, they were calculated by the Borough Engineer and Surveyors Department. The Committee has asked for a more thorough breakdown and until this is received no comment is appropriate.

The following question addressed by Mr. Councillor C.C. Thomas to the Lead Member for Regeneration and Community Advisory Committee, having been circulated together with the Lead Member's reply was noted:

Question:

Multi-Purpose Events Hall

Which other potential sites have been considered for location of the proposed 75m long 8 metre high 2700 square metre footprint steel and membrane covered sports and events hall, with alcohol and music license, for which outline planning application (PA11/01748A) has been unsuccessful to date given planning officer and committee concerns about potential disturbance, visual impact arising from scale and position, and the lack of information about the required 180 parking spaces?

Reply:

The proposed multi-purpose building the subject of the planning application was intended to optimise use of a specific area of Noble's Park, by enabling all-weather use of the newly resurfaced hard courts. As such it is site-specific and no other sites were considered.

No formal notification has been received of refusal of the planning application despite a recent newspaper article indicating it.

The following question addressed by Mr. Councillor C.C. Thomas to the Leader of the Council, having been circulated together with the Leader's reply was noted:

Question:

Ratepayer-borne non-housing-related borrowing by Douglas Borough Council for regeneration

Has Treasury concurred with, and Department of Infrastructure approved, the recent petition by the Mayor, Alderman and Burgesses of the Borough of Douglas to borrow for the purpose of payment of professional fees for electrical design work in connection with the lighting and CCTV element of the Douglas Town Centre Regeneration Scheme; and

How much is currently estimated for ratepayer-borne non-housing-related borrowing up until end-2015 and how much of this will be used for i) Douglas Town Centre Regeneration ii) proposed Cambrian Place development iii) other non-housing use.

Reply:

The petition for borrowing powers for payment of professional fees for electrical design work in connection with the Town Centre Regeneration Scheme is currently under consideration by the Department of Infrastructure and the outcome is awaited.

The calculation of rateborne borrowing for schemes other than housing is not easily or quickly achieved but the Borough Treasurer is working to gather the information requested by the Member and will supply when it is available.

The following question addressed by Mr. Councillor C.C. Thomas to the Lead Member for Environmental Services, having been circulated together with the Lead Member's reply was noted:

Question:

Plans to link south west Douglas to the town centre with a footpath and cycleway

What is the current status of the previously announced plan to enhance the right of way to pedestrians and cyclists between south west Douglas the town centre through:

- (i) The Nunnery Estate including river crossings
- (ii) Lake Road and Quay West development
- (iii) The Quays
- (iv) The proposed Lower Douglas Development Site;

What discussion about this plan have been held by Council members and officers in 2011 and 2012 with i) landowners ii) developers iii) planning officers iv) government departments v) potential users and the wider community; and

Has more general access and use of Nunnery estate for i) dog-walking ii) leisure and sport iii) allotments been discussed with landowners?

Reply:

This scheme to develop cycle and pedestrian access was originally put forward as a suggestion by a private individual and potential funding source who has since withdrawn the offer. Therefore the scheme has not been progressed.

4. Executive Committee – 25th May 2012 – Part B, Clause 2
