2. Executive Committee – 15th January 2015

Borough Rate 2015/2016

Motion moved by Mr Councillor D.W. Christian, seconded by Mr Councillor D.J. Ashford, "That the minutes of proceedings of the Executive Committee, as contained in report of special meeting held on Thursday, 15th January, 2015 and containing the recommendation;

'That in accordance with Section 11 of the Local Government Act 2006, a Borough Rate of **FOUR HUNDRED AND TWO PENCE** in the pound on the net annual value of all rateable property in the Borough be levied for the year ending 31st March, 2016.'
