### 1. Minutes – 13<sup>th</sup> November, 2019

The minutes of the monthly Council meeting held on Wednesday, 13<sup>th</sup> November, 2019, were approved and signed.

# 2. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Environmental Services Committee:

"Rates could go up due to rise in gate fees at the incinerator" was broadcast by local media in the early hours of Saturday 30th November 2019. It was announced by the Department of Infrastructure that local authority rates will have to rise by nearly 2% due to an increase in 'gate fees' at the Energy from Waste Plant. Were Council officers and or the Environmental Services Committee consulted or made aware by the Department of the proposed increases prior to any announcement from the media?

Reply by the Chair of the Environmental Services Committee:

Local authorities were notified on 8th November of the increase, and it will be taken into account by Council officers in preparing estimates for the 2020/21 revenue budget. I am not aware of the Department of Infrastructure making a statement as to the effect of the increase on local authority rates. What it actually said in the notification letter was that the gate fee for the Energy from Waste Plant would rise by 1.92%.

That is only one element of the costs of each local authority. How the increase is dealt with by each local authority, together with many other factors, will determine the rate levy.

#### Supplementary Question:

I would like to ask when the Chair of the Environmental Services Committee was first made aware of the changes and how was this conveyed?

#### Reply:

Although in my reply I say that local authorities were notified on the  $8^{th}$  of November I must underline those two words 'local authorities' not Members. The first time I was made aware of it was as a Member of the Eastern Civic Amenity site joint Committee and that was on the  $28^{th}$  November so that's when I was first made aware of it because we had to discuss it because we had to dispose of a lot of our waste through them.
