The Chief Executive, Director of Finance, Director of Environment and Regeneration and the Director of Housing and Property were in attendance.

1. **Minutes – 13th October, 2021**

The minutes of the monthly Council meeting held on Wednesday, 13th October, 2021, were approved and signed.

2. Standing Order 39 – Question – Mr Councillor S.R. Pitts

Mr Councillor S.R. Pitts asked the Leader of the Council:

- 1.1 Why was the decision made to allocate only two polling stations for each constituency at the Douglas Borough Council Elections on 22 July 2021?
- 1.2 When was the decision made and by whom?
- 1.3 Can the residents of Douglas not be treated the same at election time for both House of Keys and Council when all areas are now the same?
- 1.4 Was the Cabinet Office consulted in relation to the polling stations to be used in the General Election?
- 1.5 If the Cabinet Office wasn't consulted, did the decision maker know which polling stations would be used in each constituency and in each area within that constituency?
- 1.6 Why was there inconsistency with the Keys Elections and the designation of the polling stations, so that residents of Douglas were not treated the same in each election in some cases having to go to different polling stations when voting in the same constituency area?

Response by the Leader of the Council:

- 1.1 The decision about allocation of polling stations for each Ward in the Douglas Borough Council elections was made on the basis of which premises were available and accessible, following several weeks of research and enquiries.
- 1.2 The decision was made by the Returning Officer in late June, 2021.
- 1.3 Ideally, to avoid confusing voters, the same premises would be used as polling stations for both House of Keys and Borough Council elections. However the elections are managed separately and under slightly different legislation.
- 1.4 The Cabinet Office was not consulted over the location of the polling stations for the House of Keys elections; at the time of having to decide on the stations for the Council elections, it is unlikely that the information on which premises would be used for the Keys elections would have been available. It is also unclear that, at the time, the Cabinet Office would have an overall view of the polling stations that might have been chosen by the respective Returning Officers.
- 1.5 No.
- 1.6 The inconsistency arose because of the separate organisation behind each of the elections, but was emphasised by the proximity of the dates of the elections in 2021, which is unlikely to ever happen again.

Supplementary Question:

Would the Leader not agree that the turn out could have been a lot higher if more polling stations were available when the council elections were held on 22 July 2021 which was one of the hottest days of the year?

Response by the Leader of the Council:

Madam Mayor, I feel that better co-ordination between the Returning Officers for the respective elections might have helped ease any confusion and provided more consistency for voters.

But I do not accept the premise that more polling stations would necessarily have led to higher turnout. All voters in both elections had received a poll card advising them of the location of their polling station. Failure to vote is largely down to inertia, rather than any lack of information. It was a very hot day, but there is little that can be done about that.
