The Chief Executive, Director of Finance, Director of Environment and Regeneration and the Director of Housing and Property were in attendance.

1. **Minutes – 12th October, 2022**

The minutes of the monthly Council meeting held on Wednesday, 12th October, 2022, were approved and signed.

2. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Leader of the Council:

- 2.1 What training and qualifications (if any) are given to Council officers and staff in order that they may recognise signs and symptoms of mental health or any other disability?
- 2.2 Have any Council officers or staff received training or qualifications in recognising symptoms of mental illness or any other disability?

Reply by the Leader of the Council:

- 2.1 The following training has been provided:
 - Stress Bucket Training through Isle Listen
 - Mental Health for Line Managers through Isle Listen
 - Mental Health First Aiders through Isle Listen
 - Sunflower Hidden disabilities training through Hospice Isle of Man
 - Threatening Self Harm presentation through Superintendent Maddocks, IOM Police

Employees are not 'qualified' in mental health or disability and are not expected to be experts in mental health.

Training has been provided and this allows for mental health to be managed in the workplace. The mental health wellbeing training provided guidance on how to spot the signs that someone may be experiencing mental ill health. Managers and employees know where they and staff can go for further support internally (such as mental health champions, and mental health first aiders) who are there to signpost to external services.

Wellbeing support is also provided via DBC's Wellbeing Group.

A number of staff have been trained as mental health first aiders and wellbeing champions are available to staff who may wish to utilise this provision.

There is still a lack of understanding about mental health and staff are being encouraged to talk to their line managers about their mental health. If staff do not wish to speak with their line manager then they can speak to a named mental health first aider or wellbeing champion. Involving staff and educating the workforce about mental health is important.

The Council is committed to promoting positive mental health across the organisation, this is an encouraging cultural shift.

2.2 The following training has been provided:

•	Sunflower Hidden disabilities training	(37 employees)

Reply by the Leader of the Council:

Thirteen.

4. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Housing and Property Committee:

4.1 Does the Council have a duty of care for its tenants and if so, under what legislation or regulation?

4.2 What course of action would be taken should an officer or member of staff recognise or feel that there may be cause for concern with a tenant who they consider may have mental health issues or any other disability?

Reply by the Chair of the Housing and Property Committee:

- 4.1 Yes, as contained in the following acts and regulations:
 - Housing Act 1955;
 - Safeguarding Act 2018;
 - Equality Act 2017;
 - Landlord and Tenant Act 1954;
 - Landlord and Tenant (Miscellaneous Provisions) Act 1976.
 - Housing (Standards) Regulations 2017.
- 4.2 Staff will discuss with the individual in the first instance. The case will be escalated to the relevant management level. The case may then be referred to other support agencies who are specialist in the relevant field. In some instances, this will need the tenants' permission, however if it's a safeguarding issue, the case will be referred to the safeguarding board and other relevant Government departments.

5. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Environmental Services Committee:

- 5.1 Given the unusual weather conditions of late and the changing of the seasons with many species still in bloom does the Chair think that the cessation of the "green waste" collection from the week commencing 31st October premature?
- 5.2 How many complaints to date have been received and logged since the commencement of the fortnightly refuse collection?
- 5.3 How many complaints have been received and logged to date in respect of "green waste" collection?
- 5.4 Does the Chair feel that the commencement of the fortnightly refuse collection to initially to have been a success?

Reply by the Chair of the Environmental Services Committee:

- 5.1 The Environmental Services Committee at its next meeting will receive a report on extending the garden waste service until November, starting in 2023. The service in the short time it has been running has proved popular and requests to extend the service are being addressed. The garden waste service could not be extended this year due to the timing of the Council's decision-making process and the operational timeframe needed to make such changes.
- 5.2 There has been one formal complaint submitted about the change in Waste Strategy. The complaint concerned the decision rather than issues about service provision, that is, the complainant did not complain they could not manage, more that they did not agree with the decision made. Council Members and officers have answered many queries about the change in service but to date, these have not resulted in complaints being received and logged.
- 5.3 None.
- 5.4 The purpose of the change in Waste Strategy was to significantly increase the Council's recycling rate. After introduction of the garden waste service, which is still in its infancy, and before the commencement of fortnightly refuse collections, the Council's recycling rate had doubled. Therefore the change in waste strategy is achieving its objective and on that basis should be deemed a success. It is inevitable with a change of this magnitude that some residents would be dissatisfied and concerned, and Waste Services will continue to work with these residents to assist them in the transition to the new Waste Strategy and provide extra capacity where that is needed.
