The Council is seeking to tender for the services of an experienced contractor to provide a Media Service on behalf of Douglas Borough Council, such service to include press releases, editorial support, coverage of events, and copy for publications.

In submitting a tender all applicants must agree to the terms and conditions of engagement contained within this document and comply with the Council's Media Contact Policy.

Tenders will be judged on a number of criteria including cost, quality of work (as assessed by portfolio), experience and availability. Shortlisted applicants will be required to attend an interview as part of the evaluation process.

The framework for the service comprises:-

- ➤ Attendance at Mayoral, civic, and newsworthy events, averaging
 - 4 Mayoral events per month.
 - 8 Civic events per annum (specifically Mayor's Installation, Civic Sunday, Business Reception, Fun Day, Fireworks Display, Remembrance Sunday, Armistice Day, Christmas Lights Ceremony).
 - o 10 events monthly relating to Council news/initiatives.
 - o 10 internal Digital Media Group meetings per annum.
 - o 12 Council meetings per annum.
 - 48 hours' notice of attendance at events to be standard.
- Preparation and issue of press releases in connection with events as above.
- > Updating and reviewing specified elements of the Council's website.
- > Copy for publications.
- > Monitoring local media.
- > Editorial support.
- ➤ Contract length three years to commence 1st June 2018. To be terminated by three months' notice by either party.
- ➤ Major media projects will be separately procured.
- > Liaison with Council officers regarding the Council's social media communications.
